

The employer collects the membership fee according to the amount indicated separately in writing by the local branch or union from the employee's gross pay sum from which tax is withheld. The amount is announced as a single percentage or sum in euro for a full calendar year at a time. The sum cannot be changed during this period. The membership fee for 2020 is 1.5% (2019: 1.5%). The employer is not responsible for incorrect information submitted by the employee, local branch or union.

This agreement enters into force from the beginning of the next full collection period following the employer's signature date and remains valid until further notice, or until the employer's membership in the employer association ends, an agreement between organisations is made to terminate employer collection, or until the employment or union membership ends. If the employee terminates this agreement, its validity will end after the next full collection month following the termination. However, the authorisation for employee collection will continue automatically if the fixed-term employment contract of a PAM member continues within three months with the same employer.
